The purpose of the hearing is to receive comments from all interested parties regarding the adoption of regulations that pertain to R050-15, Chapter 637B of the Nevada Administrative Code.

The proposed regulation will provide clarity for the public, individuals and licensees regarding requirements to apply for, renew, reinstate or change the status of a license to practice speech-language pathology, audiology or fitting and dispensing of hearing aids; prescribe the date on which an active and provisional license expires; update the definition of “Board” to reflect the new name and providing other matters properly relating thereto
