# Notice of Hearing for the Adoption of LCB File No. R064-21 of the Speech-Language Pathology, Audiology and Hearing Aid Dispensing Board

The purpose of the hearing is to receive comments from all interested parties regarding the adoption of regulations that pertain to LCB File No. R064-21, Chapter 637B of the Nevada Administrative Code.

# 1. Need for and Purpose of the Proposed Regulations or Amendments

The need for the proposed regulations is to protect the public health, safety, and welfare by ensuring that only qualified and competent speech-language pathologists, audiologists, and hearing aid specialists are licensed in the state.

#### 2. Terms of the Regulations to Be Adopted

The purpose of the adopted regulation is to provide clarity for the public, individuals, and licensees through regulations.

Existing law requires the Speech-Language Pathology, Audiology and Hearing Aid Dispensing Board to adopt regulations prescribing requirements for the renewal of a license or endorsement issued by the Board. (NRS 637B.191) With certain exceptions, existing regulations require a licensee to complete 15 hours of continuing education as a prerequisite for the renewal of a standard license or provisional license. (NAC 637B.400)

#### This regulation does the following:

(1) Reduces, from 15 hours to 10 hours, the total number of hours of continuing education required for the renewal of a license; and

(2) Requires at least 1 of these hours to relate to ethics, cultural competence, cultural humility, culturally responsive practices or diversity, equity and inclusion.

If a licensee is a dispensing audiologist, existing regulations require at least 5 hours of continuing education to relate directly to the practice of fitting and dispensing hearing aids. (NAC 637B.400) This regulation reduces the requirement from 5 hours to 3 hours.

#### 3. Estimated Economic Effects

#### 1) On the Business Which It Is to Regulate

#### (a) Adverse and Beneficial Effects

The Board used informed, reasonable judgment in determining that there will not be an adverse impact on small businesses due to the nature of the regulation changes. In making this determination, the Board considered whether or not the speech-language pathology, audiology, and hearing aid dispensing practitioners regulated by the Board will have their practice impacted. Conversely, small businesses will benefit from the reduction in hours required for continuing education which will reduce costs for licensees, allow for more time spent on clinical care, and align professional development with national standards.

#### (b) Immediate and Long-Term Effects

The immediate effect will be to improve and clarify existing law and regulatory requirements. Long-term, small businesses may experience the effect of having more knowledgeable practitioners with reduced monetary and time costs for continuing education.

#### 2) On the Public

#### (a) Adverse and Beneficial Effects

The Board used informed, reasonable judgment in determining that there will not be an adverse impact on the public due to the nature of the regulation changes. In making this determination, the Board considered whether or not the continuing education requirements for speech-language pathology, audiology, and hearing aid dispensing practitioners regulated by the Board will create a risk to the public. Conversely, the public

will benefit from the reduction in hours required for licensees to engage in continuing education which will allow for more time spent on patient care and align professional development with national standards.

#### (b) Immediate and Long-Term Effects

The immediate effect will be to improve and clarify existing law and regulatory requirements. Long-term, the public may experience the effect of having more knowledgeable practitioners who engage in professional development that aligns with national standards, allows for more time spent on patient care, and reduces costs for practitioners that might otherwise be passed on to patients.

# 4. Estimated Cost to the Agency for Enforcement of the Proposed Regulation

There are no additional costs involved in the enforcement of these proposed regulations.
